This should be available by the time we get to our March – April billing cycle on the first of May, 2006. If you are interested in automatic payment deductions for your water and sewer bills, you will need to request, fill out, sign and return a direct payment authorization form to our office. We will need original signatures and current bank information on file to perform this service.

Domestic Water Hookup Fees to Increase on July 1st

Beginning on July 1, 2006 hookup fees for domestic water will increase to \$3,980 per equivalent residential unit (ERU). This increase reflects the large capital improvements that were made on behalf of prospective growth on the domestic system together with the early payout of domestic revenue bonds on past projects. New pumps were added to both domestic intakes together with new motor control centers at a cost of over \$540,000. 20-year revenue bonds were also paid off six years early saving the District over \$140,000 in interest payments. The objective of hookup fees is to insulate existing users as much as possible from the cost of growth. Sewer hookups will remain at \$3,315 per ERU.



Reminder: Payments on Bills are due within 30 Days

Now that our new billing software is up and running, you may have received and noticed that the friendly reminders show both the amount that was due prior to the end of the previous month and the amount due if the original due date has passed. The new amount due after the original due date includes interest as prescribed by the District rules and regulations. We have been giving a grace period of 10 days for the past six months before actually charging for the interest or a late fee. This is a reminder that as of the January – February billing period (due March 31, 2006), the interest will now be due and payable per the requirements of the state auditor. Keep in mind also that we bill in arrears and you will have received service for around 90 days prior to the interest bearing deadline. Thanks for your understanding!
